Tents

Vendors are strongly encouraged to obtain a tent as there is no shade/rain protection on grass. All vendors should have weights available in case of strong gusts of wind.

Tables and Chairs

All vendors are required to supply their own tables and chairs.

Electricity can be provided for an additional \$25.00.

Sales People at the Tents

Two admittance tickets will be available to each vendor. Discounted tickets are available for additional staff members. People knowledgeable of the items for sale must be present in vendor tents at all times during the LOUD Fest. No one under 21 shall be allowed to attend to the vendor space.

- All vendors will display their products in a clean and safe manner.
- At the close of the show, vendors will clean their immediate area and remove all boxes, packing materials and trash.
- Vendors should operate their business in a professional manner at all times.
- All vendors will be responsible for the actions of their employees and/or agents.
- Possession of weapons and/or firearms, fireworks, gambling, or disorderly conduct by a vendor or his/her employees will result in immediate removal from the event.

All vendors are expected to carry their own liability insurance.
